# Virtual Tech Trek 2021

Our branch is pleased to sponsor ten girls for this year's Virtual Tech Trek event!

Three of eight girls nominated at Modesto's Prescott Junior High School and two of five candidates from Turlock Junior high completed our Tech Trek application process. These five seventh grade girls have been interviewed and selected to attend Virtual Tech Trek in Summer 2021. For the first time, parents were also interviewed this year; this new practice will be a part of the process in the future.

2020 Tech Trek girls will be attending camp this summer as all of Summer 2020's camps were cancelled. Five of six girls we selected last year will attend the Virtual Camp.

Each attendee selected one of three camp sessions that were offered from June 21 to 25, from July 12 to July 16 and from July 26 to 30. Each camp is centered on a morning-based project on robotics/engineering/coding class that meets daily and results in a personalized creation.

In the afternoon, girls will hear inspirational women speakers and participate in a variety of 90-minute hands-on science, technology, engineering and math workshops. Participants may return in the evening for activities with girls from other countries or for social activities.

We extend our thanks to teachers from Prescott who nominated students, Prescott Counselor Kella Clark who again served as coordinator at her school and Donna Creighton, STEM elective teacher/coordinator at Turlock Junior High School.

In addition, we appreciate Turlock coordinator Valerie Doherty and Modesto coordinator Beverly Schlegel and Branch members Fran Ewald, Pam Mayne, Pat Portwood, Marylou Hacker Rousseau, Margo Souza and Sheila Younkin who read applications, interviewed girls and parents and selected this year's participants.

# AAUW-CA's Top 3 Bills

AAUW-CA identified its top three bills going before this legislative session. These bills address issues in our society that disproportionately affect girls, women, and people of color and were presented by members on AAUW-CA Lobby Day in March.

**CA AB92** will temporarily waive, and then reduce, fees low-income families pay for childcare. State and federally funded programs help families with the cost of daycare, but families must still pay fees. This can make subsidized care unaffordable for many. This bill will waive family fees, using federal funding, through October 31, 2022. It will provide immediate relief for these low-income families, similar to what the Legislature did last year at the beginning of the pandemic.

After that, the bill will create an equitable sliding scale for reasonable family fees.

This is AAUW-CA's signature bill and we are a co-sponsor of this legislation. **CA SB62** Currently, garment workers are paid by the piece rate rather than being paid legal wages for time spent working. The piece rate often results in subminimum wage rates. This legislation eliminates piece rate in the garment industry and assures workers are paid for all their work.

**SB373** will prohibit creditors/debt collectors from being able to collect from individuals who can show the debt was incurred through economic abuse. It primarily focuses on survivors of domestic abuse, and foster youth. Debts taken out in their names without their knowledge damage their credit and may force them into years of debt repayment.

# AAUW National Election 2021

#### It's your AAUW, and your voice counts.

AAUW national voting is now open. For this vote, members are asked to elect representatives to the national AAUW Board of Directors, to consider changes to the bylaws that would open AAUW membership and also on changes to our Public Policy Priorities.

If you have an address listed with AAUW, please check your email folder (spam/junk also) for information needed for you to vote. You may vote on your computer, a pad or your phone. Members with no email listed have already been mailed ballots. If you wish to vote by mail, you must contact AAUW at <u>connect@aauw.org</u> or call 800.326.2289 to request a paper ballot by April 17. Paper ballots must be postmarked by Friday, April 30, 2021.

### 2021 Bylaws Amendment

AAUW has survived because of our ability to change. Our original mission going back 140 years was to "unite graduates" and support women in getting higher education at a time when women needed that. In 2009 we changed our purpose to "advancing equity for women and girls" as we recognized the inequities facing them in the world. Today, the challenges for women and girls are underscored by inequity and social injustice.

Now AAUW members can vote on proposed changes to the bylaws recommended by the AAUW Board of Directors and AAUW Governance Committee **that would eliminate the degree requirement for membership**. Your vote could be impactful since passage of this bylaw amendment requires a 2/3 majority of votes received.

The listed rationale of the proposed Bylaws Amendment is as follows: <u>AAUW's mission is to advance gender equity, yet the requirement for membership explicitly</u> <u>denies access to membership to those without college degrees. AAUW does not promote</u> <u>equity for all women and girls if the organization maintains exclusionary membership</u> <u>requirements. The membership requirement is not fair, is not right, and is not equity. This is</u> <u>simply the right thing to do.</u>

### **Public Policy Priorities**

AAUW's Public Policy Priorities, adopted every two years by every-member vote, establish the federal action issues on which AAUW members across the country focus their advocacy efforts and guide the work of the national staff. States and branches also use the Public Policy Priorities to inform their advocacy efforts on state and local issues.

The strength of the AAUW Public Policy Priorities is that they originate and end with the membership. Last fall (and the fall of all even numbered years) the AAUW Public Policy Committee (APPC) solicited feedback from members and staff to develop proposed Public Policy Priorities based on viability, critical need, strong member support, and potential for distinctive contribution. Once the draft was developed, it was posted online for a comment period. The comment period expired and APPC finalized the current proposed Public Policy Priorities. Our AAUW Board of Directors approved them. AAUW members can now vote on these proposed changes.
